The risks include, but are not limited to, shooting accidents, injuries caused by ammunition, injuries caused by firearms/weapons, projectile ricochet, vehicle accidents, injuries caused by domestic, feral and/or wild animals, snake bites, diseases and organisms carried by animals, Valley Fever, poison oak, slipping, falling, cuts, burns, lifting, hiking, running, etc. It is also probable that medical attention and/or services will not be available in the event of any injuries to me or others as a result of participating in the Activities.
